SUBJECT: Limited Increase in Rates for Newly Established High-Risk Actuarial Areas in Arkansas

I. BACKGROUND

The Risk Management Agency (RMA) reviewed and updated the high-risk actuarial maps for counties in Arkansas for the 2023 crop year. Some land was added to the high-risk land area and resulted in increased premium rates for those areas. After further analysis, RMA will limit the amount of increase in rates for those areas by decreasing the actuarial (high-risk) rates currently published for the *newly established high-risk areas*.

II. COUNTIES AFFECTED

The counties affected are the following six (6) counties in Arkansas: Craighead, Greene, Independence, Jackson, Lawrence, Randolph.

III. BLANKET WRITTEN AGREEMENT OFFER

RMA will issue a blanket written agreement offer for all Farm Serial Numbers (FSNs), Farm, Tract, fields, in *newly established high-risk areas*, for the counties and crops listed below. The blanket written agreement will apply to the 2023 crop year. Newly established high-risk land designations (BBB, CCC, DDD, etc.) with the rates and written agreement numbers listed in the following table:
